ADMINISTRATIVE ORDER NO: 2020-12

RE: ESSENTIAL SERVICES PROVIDED BY EMPLOYEES OF THE CLERK OF THE COURTS AND THE FOURTH JUDICIAL CIRCUIT IN NASSAU COUNTY

WHEREAS, in response to the COVID-19 virus (coronavirus) pandemic, the Governor issued Executive Order 20-91 on April 1, 2020, directing that all Florida residents stay at home and restrict their movements and personal interactions to only those "necessary to obtain or provide essential services" until April 30, 2020;

WHEREAS, Executive Order 20-91 recognizes that workers providing essential services include both "workers supporting the operation of the judicial system" and "federal, state, ..., and local [government] employees who support Mission Essential Functions and communications networks;"

WHEREAS, the Clerk of the Courts for Nassau County is the entity charged with both supporting the functions of the circuit and county courts and authorizing and paying all county bills in the Clerk's capacity as the comptroller which is a "Mission Essential Function;"

WHEREAS, the employees of the Nassau County Clerk of the Courts, working with the judges, and court personnel of the Fourth Judicial Circuit, provide essential services to the citizens of Nassau County, Florida;

WHEREAS, many of the employees of the Nassau County Clerk of the Courts and the Fourth Judicial Circuit working in Nassau County reside near the state border in Georgia and there is a need to identify those employees for the authorities in Georgia for purposes of traveling to and from work;

WHEREAS, the Chief Judge of the Fourth Judicial Circuit has delegated authority to the Administrative Judge for Nassau County to establish temporary procedures;

NOW THEREFORE, by the authority vested in the undersigned, IT IS ORDERED:

- 1. The employees of the Clerk of the Courts and the Fourth Judicial Circuit listed in the attached Appendix "A," provide essential services to Nassau County, Florida and are exempt from Executive Order 20-91 governing the state of Florida;
- 2. The authorities in the State of Georgia are requested to allow travel to and from the Nassau County Courthouse for the employees listed in the attached Appendix "A".
