FORM 980 (I) MOTION FOR EXTENSION

Family law forms can be electronically filled out and printed at your convenience at the Florida State Courts website (www.flcourts.org), select Self Help, Family Law Forms.

PLEASE READ CAREFULLY

This process is similar to filing for a new injunction. If a Respondent cannot be found and served your request for an extension may not be granted in open court. If that may occur, you must file a New Petition for Injunction on new claims.

- ☐ You must know the other **party's current or last known address**. The Domestic Violence Office **CANNOT** provide you with any information about the other party.
- Motion for Extension <u>must</u> be filed within fourteen (14) days <u>prior</u> to the Final Judgment of Injunction expires.
- There must have been <u>recent acts</u> (3-6 months) of violence, threats, and/or you as the Petitioner feel that the Respondent is an <u>imminent threat</u> to your life. You may include <u>recent</u> police reports or any violation of injunction that may have occurred within the past 3-6 months.
- Motion must be notarized by a notary public with a valid proof of identification or be stamped by a deputy clerk. Proper identification is necessary.
- Your court date for your Motion for Extension will be scheduled two (2) weeks from the day you file your motion. The court date must be scheduled on or before the expiration of your injunction. You will receive a **Notice of Hearing** with your assigned date once a case manager has reviewed your motion and file it with the Clerk of the Court.
