- If you are the <u>Respondent</u> Filing a <u>Motion for Modification</u>, a copy of your notarized motion must be provided to the Petitioner. You may choose to pay \$50 to have the sheriff's office personally serve the other party with motion **OR** you may choose to have the motion certified mail with a return receipt at the postal office for \$5.75 (price may change without notice).
- Motion for Modification can be used to make any <u>changes</u> to the Final Judgment of your injunction. Express <u>briefly</u> WHY you want to change part of the injunction and HOW you want the Final Judgment to be changed.
 - BRIEF EXAMPLE of WHY's
 - The Respondent has been violating the injunction and continues to contact me. I am in fear that I will be harmed.
 - I can no longer afford the BIP classes and I do not have any ride to get there.
 - BRIEF EXAMPLE of HOW's
 - I respectfully ask the Court to modify the injunction to NO CONTACT with the Respondent but only through a third party about the children.
 - I would like to have the BIP classes removed from the injunction requirements.
- Motion must be **notarized by a notary public** with a valid proof of identification or be stamped by a deputy clerk. <u>Proper identification is necessary</u>.
