- ❖ A foreign judgment is a judgment or order issued by a court of another state or country
- ❖ A court of this state shall agree to full faith and credit to an order issued by another state
- Full faith and credit is the requirement that judicial proceedings, (as well as public acts and records) shall be extended the same effect by the courts of another sate that they have in the state of origin
- An order of final judgment can only be modified by the court issuing the order or final judgment, unless it has been registered and/or recognized by another state court

- **5.** The Clerks Office will issue the **Summons** (instructions on next page).
