## ADMINISTRATIVE ORDER 2020-08

IN RE: COVID-19 JUVENILE DEPENDENCY ORDERS REGARDING VISITATION

WHEREAS the World Health Organization has declared the outbreak of the Coronavirus Disease 2019 (hereinafter "COVID-19") a pandemic, the Governor of Florida has declared a state of emergency exists, the Mayor of Jacksonville has declared a state of emergency exists, the Florida Education Commissioner has suspended school until April 15, 2020, and the Surgeon General and State Health Officer have declared a public health emergency exists;

WHEREAS the Florida State Courts System must continue to take steps to mitigate the effects of COVID-19 on the courts, court participants, and the general public; and

WHEREAS on March 13, 2020, the Supreme Court of Florida entered Administrative Order No. AOSC20-13 regarding COVID-19 Emergency Procedures in the Florida State Courts, thereby suspending grand jury proceedings, jury selection proceedings, and criminal and civil jury trials during the period of Monday, March 16, 2020, through Friday, March 27, 2020, or as provided by subsequent order; and

WHEREAS, it is the interest of this order to have the Community Based Care Providers' and Case Management Organizations fulfill their responsibility to the Court, the children and the parents to conduct visitation essential to the physical, mental and emotional health of children, their parents and caregivers in the safest manner possible while maintaining parent, child and sibling relationships; and

WHEREAS, it is the intent of this order to direct the Department of Children and Families and its contracted agencies to postpone physical face to face visitation until April 15, 2020, or as further ordered by this Court.

NOW THEREFORE, pursuant to the authority conferred upon me as the Chief Judge of the Fourth Judicial Circuit and pursuant to the Florida Rules of Judicial Administration, it is hereby

## **ORDERED** that:

- All orders issued by the Circuit Courts of the Fourth Judicial Circuit requiring the Department of Children and Families and its subcontracted agents to make children available for physical contact visitation are suspended until April 15, 2020, or as further ordered by this Court.
- All orders issued by the Circuit Courts of the Fourth Judicial Circuit requiring parents to attend physical contact visitation are suspended until April 15, 2020, or as further ordered by this Court.
- 3. The Department of Children and Families and its subcontracted agents shall employ face to face virtual visitation through electronic means such as Zoom, FaceTime, Skype or another such type program that allows the child(ren) to see their parent(s) and the parent(s) to see the child(ren). This order does not support any specific such electronic application over another.
- 4. Virtual visitation shall include non-visual text messaging, video messaging, audio/visual recording, voice calls and virtual face to face visitation.
- 5. The Department of Children and Families and its agents shall create Family Time Virtual Plans for electronic visitation that take into consideration the following: the age and maturity of the child(ren), the emotional and mental health of the child(ren), the daily schedule of the child(ren), caregiver and parent, the behavior of the child(ren) and behavior of the parent. The Family Time Virtual Plan will be as specific as possible in terms of scheduling as a set routine schedule is best for children.
- 6. The Department of Children and Families, Community Based Care Providers, Case Management Organizations, and the children's caregivers will supervise visitation with the parent or will select another individual to do so.
- 7. Should the parent or another party be of the opinion that the visitation must be conducted as physical in-person visitation, the party must file an appropriate motion with the court requesting such relief and a hearing will be conducted remotely.
