SECOND AMENDED NOTICE REGARDING FELONY CRIMINAL COURT CALENDARS/ HEARINGS IN THE FOURTH JUDICIAL CIRCUIT, DUVAL COUNTY, FLORIDA

As we monitor the ongoing developments regarding COVID-19 virus, and with the entry of AOSC20-23, the eight (8) felony judges within the Fourth Judicial Circuit, Duval County, Florida are modifying the previously implemented changes as described below effective until May 29, 2020. We appreciate your continued patience and understanding as we take measures to protect the community. Please check <u>duvalclerk.com</u> for court dates. All jury services have been canceled until May 29, 2020 and speedy trial has been tolled.

<u>APPEARANCES:</u> All regular personnel, including attorneys, interpreters, witnesses, probation officers and court reporters shall appear via Zoom. Personal appearances are prohibited unless specifically authorized. Please contact the appropriate division JA for the Zoom meeting ID number.

OUT OF CUSTODY CASES:

Arraignments: When an attorney files a Waiver of Appearance and Plea of Not Guilty (and other pleadings), per the Criminal Rules prior to the arraignment, the clerk will administratively pass the case to a pretrial date which will be available on CORE. No appearance will be required of the defendant or counsel. A copy of the Waiver of Appearance and Plea of Not Guilty MUST be emailed to the appropriate judicial assistant. This applies to arraignments only. If defense counsel has been unable to contact the client, the defendant is to appear. At the front entrance the defendant's contact information will be obtained, a four week pass date will be provided and the defendant will be excused. The defendant's appearance will be documented and provided to the 601 and 602 clerks, Judges and PDs and will be reflected in CORE.

<u>Pre-trials:</u> All defendants' appearances can be waived. Please prepare a waiver of speedy trial form, if appropriate and submit to the division presiding judge. All final pre-trials will remain on the calendar for the trial to be addressed and reset within speedy trial times (accounting for the period which it has been tolled) or at a mutually convenient time if speedy has been waived.

<u>Negotiated Pleas:</u> The Court will take pleas on out of custody defendants at this time ONLY if the Defendant's case does not involve incarceration. Counsel should contact the presiding Judge for scheduling of said pleas.

IN CUSTODY CASES:

<u>Arraignments and VOP service of the Rule:</u> All in custody cases will be handled remotely. Please note: Cases are called in the order of the defendant's housing location in the following order: MCC Females, MCC Males, CTC, PDF Females, PDF Males starting on 2nd floor to 6th floor.

<u>Pre trials:</u> These cases will be passed administratively four weeks from the pretrial date. **All final pre-trials** will remain on the calendar for the trial to be addressed and reset within speedy trial times (accounting for the period which it has been tolled) or at a mutually convenient time if speedy has been waived. The defendant will appear remotely.

<u>Negotiated Pleas:</u> All negotiated pleas will be taken including any pleas involving incarceration in the county jail, prison and/or probation. These will be handled in courtroom 503 every day, except Friday. To have a case added for disposition, your request to add MUST be submitted to duty judge for courtroom 503 by **NOON on the day prior to your requested disposition day** (counsel may not request a time certain—cases will be added on a daily basis) and must comply with the following:

- 1- Information must be filed.
- 2- The plea form must include signatures from counsel, Assistant State Attorney and Defense counsel. (Including VOP admission and negotiated sentence-form 8) and must indicate the Defendant's verbal affirmation.
- 3- All case related information provided must be correct.
- 4- Defendant must be in custody.

Bond motions: To have a case added for a bond motion, please contact the presiding Judge to schedule a hearing on your Motion.

<u>Cases pending Sentencing:</u> These cases will be handled by the presiding Judge of each division. Please contact the presiding Judge to schedule a sentencing hearing.

<u>Post Conviction Evidentiary Hearings:</u> (This applies only to those cases where the defendant had already been transported for a hearing) .These cases will be handled by the presiding Judge of each division. They will be handled remotely and must be scheduled by the presiding Judge. Please contact the presiding Judge's office to be given a court date and courtroom.
