All **uncontested dissolutions** are heard at ex parte and **MUST** have a checklist fully completed before presenting your case to the Judge. Completion of the Putting Children First is required for Dissolution **and** Paternity actions. Zoom information and telephone numbers will be provided by the Court at the time of scheduling.

In-person appearances are allowed. Any person appearing in-person must have a personal device with Zoom capability.

**MOTIONS TO SET FOR TRIAL:** Trials will be scheduled at a time certain Case Management Conference via Zoom with the Judge on Ex-Parte dates. The parties shall submit a completed Trial Set Memoranda, including the desired mediator and trial date as an e-mail attachment to [jennw@coj.net](mailto:jennw@coj.net) prior to the Case Management Conference. Any disagreements on mediators or trial dates shall be included in the email along with each party's recommendation.

**Default Final Hearings**

Default final hearings **must be set** on the calendar for a **10 minute** hearing. This matter cannot be handled during Ex Parte.
